

**TENDER SPECIFICATION OF IP BASED GENERAL BROADCAST AND SRE SYSTEM WITH ACCESSORIES - BNS SHER-E-BANGLA**

**INTRODUCTION**

1. For better understanding and to evaluate all the prospective BIDDERS on same platform, the tender specification has been divided into three parts:

2. Prospective BIDDERS are to comply with the requirements and terms & conditions mentioned in Part-1, Part-2, and Part-3 of the tender specification. BIDDERS are also to provide performance/technical data, brochure, specific figures, and information as asked against each condition.
3. Prospective BIDDERS are to submit their offer in single envelopes (Technical and Financial Offer).
4. BIDDER shall comply all the terms and conditions of the tender documents as compliance statement by the Bidder under the following tabular format:

The financial quote is to be submitted separately in foreign currency on FOB basis, but compliance/remarks are to be indicated in the technical offer.

**PART I : GENERAL INFORMATION AND BIDDER'S RESPONSIBILITY**

5. Bangladesh Navy (BN) plans to procure one complete set of **IP Based General Broadcast & SRE System** with cables and necessary accessories which will be incorporate within existing backbone network system .
6. **Installation Site.** **BNS SHER-E-BANGLA** at PATUAKHALI.
7. **Qualification of Bidder.** Manufacturers of General Broadcast System or their authorized distributor/ agent can submit quotations through their authorized local agent in Bangladesh. In case of offer from foreign trading companies/ distributor/ agent, certificate of dealership/ agencyship from Original Equipment Manufacturer (OEM) or authentication certificates of OEM authorized local agent is to be submitted with the offer. In this regard the following certificates are to be submitted with the offer (if not OEM):
  - a. Authorization Certificate from OEM.
  - b. Supply Assurance Certificate from OEM.
8. **Compliance Statement.** A compliance statement fulfilling all the requirement of the tender is to be submitted for evaluation of the quotations. Stating mere 'Yes or No' will not suffice and detailed evidences with description/ information, brochures/ booklet, drawing and diagram as required is to be given. An incomplete compliance statement may attribute to cancellation of the offer. If any clause of this specification does not commensurate with offered System, the deviation has to be spelt out clearly.
9. **Equipment Manufacturer and Reliability/ Requirement.** The items should be brand new, unused and of recent model, proven reliability in the field of operation. The supplier shall ensure the continuity of the operation and availability of necessary spares for at least 15 years each in case of obsolete model over time.
10. **User List.** List of users of the offered systems is to be mentioned with full address. The list shall provide the name of various users with respective model and brand of the system. The offered system should be widely used by various users. The user list shall be used for the assessment of the offer.

Non-submission of said documents is to be treated as non-compliance or disqualification of the offer.
12. **Acceptance/ Rejection of Bid.** DGDP/ BN reserves the right to accept or reject any bid or to terminate the bidding process and reject all bids at any time prior to the contract award (without thereby incurring any liability to the BIDDER).

29. **Power Supply.** The system shall run with available power supply (220V AC, 50/60Hz, 1Ph) and 24 Volt DC emergency power supply. Provision should be made to switch over automatically to 24V DC emergency supply instantly, if AC fails. Bidder is to provide necessary emergency supply items (backup supply arrangement). Details of the power supply and power consumption are to be mentioned with the offer including emergency supply arrangement.

30. **Operation.** The broadcast system is remain standby continuously and should activate when the microphone switch is pressed/ ON. When the alarm push is activated the system shall immediately override the microphone input. The alarm signal shall be heard only as long as the push is pressed. When microphone switch is pressed/ ON it shall override the audio input immediately. Individual zone control with selection of all zones in priority basis should be incorporated with the broadcast system.

(28) **Standard Accessories.** Standard Accessories must include (e.g. Pre Amplifier, Line matching, Transformers, Microphones, jack, sockets, box etc) every item and accessories, which are essential to install and operate the General Broadcast with full functionality whether those are mentioned in the specification or not with purpose. A list of such items/accessories shall have to be provided inclusive of equipment price. Unit price of main amplifier and speakers are also to be quoted with the offer.

(29) **Software and Backup Software.** Supplier is to provide all related software OS and backup software (original licensed copy) to BN in CD/DVD/Flash drive format with step by step installation instructions. The list of such software is to be submitted with the offer.

(30) **Underground Cable Laying.** Underground cable laying work shall be done by bidder. Cost of boring (if required), underground cable laying and installation work shall be quoted and submitted with offer. Moreover, A detail plan and layout diagram of such work is to be submitted with offer by bidder.

35. **Local Training.** A group of operators/ technicians shall be trained locally in Bangladesh for 05 (Five) working days by the Manufacturer's/ Supplier Engineer on completion of installation and Test/Trial. Cost of air fare (to and from Bangladesh (installation site), accommodation, food and internal transportation (to and from work site and hotel) of the Manufacturer's engineer shall be borne by Supplier. The cost of local training is to be quoted with the offer separately.

a. **Training Objective.** Objective of training is to learn about the functionality and maintenance of newly installed General Broadcast System.

b. **Training Contents.** The contents of the training should include following (but not limited to):

- (1) System composition, configuration, principle of operation and troubleshooting.
- (2) Software installation, operation and configuration for smooth conducting of all the tests.
- (3) Theoretical concept and procedure of tests (practical).

36. **Installation, Supervision and Setting to Work (STW).**

**PART III: TERMS AND CONDITIONS**

38. **Delivery.**

a. **Delivery and Installation Time.** Item delivery and installation as per scope of supply shall be completed within 15 (Fifteen) months and breakdown of said time line is appended below:

(1) **Delivery Time.** The items shall be delivered to the "Place of Delivery" within **09 (Nine)** months after signing the contract.

(2) **Installation Time.** The IP based General Broadcast System shall be installed within **06 (Six)** months after delivery of the items.

b. **Place of Delivery.** NSD, Khulna.

c. In case of CFR/CPT, the supplier shall carry the items from any sea port/ air port (as applicable) to NSD Khulna at the cost and risk of supplier.

39. **Shipment.**

a. **Source of Raw Material.** To be mentioned.

b. **Source of Supply.** The source of supply of the offered systems are to be mentioned. It should be from the country of manufacturer or country of origin.

40. **Project Timeline.** A forecasted project timeline indication month-wise event is to be provided with the offer and another reviewed project time line with project implementation plan is to be submitted after 15 days of signing the contract.

41. **Warranty, Guarantee and After Sales Service.**

a. **Warranty.**

(1) 12 (Twelve) months manufacturer's warranty for trouble free operation is to be provided for the item from the date of acceptance by the purchaser. If any component and submit of the supplied items becomes defective during the warranty period, the overall warranty shall be extended automatically for the period of subject component remains defective.

This BG shall remain valid until the warranty period of the supplied IP Based General Broadcast System and other items (notwithstanding minor deficiencies which would be mutually settled and agreed between PURCHASER and BIDDER) in Bangladesh, and it shall expire on receipt of **Warranty Completion Certificate**. If the contractual obligation warrants the extension of the validity of the BG, the BIDDER shall remain liable to do so at its own cost. (3) "Packing List" signed by the authorized representative of the shipping company or exporter.
